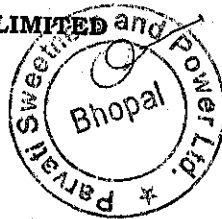



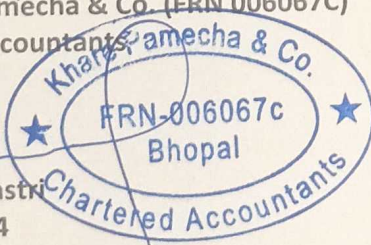
#### **Emphasis of Matter Paragraph**
