Review report to the Board of Directors of **Parvati Sweetners & Power Ltd.**

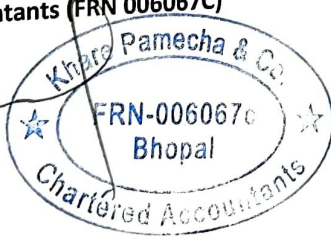
