Govt's silence on transport scam raises questions

LoP Umang Singhar demands probe

Bhopal: Leader of Opposition Umang Singhar has raised serious concerns over the transport scam in Madhya Pradesh, questioning the government's silence on the issue. Addressing a press conference, Singhar pointed out that while Prime Minister Narendra Modi talks about 'zero tolerance' against corruption, multiple scams are taking place in the state without any discussion in the assembly.

Highlighting the transport scam, Singhar alleged that a nexus of ministers, officials, and contractors has been illegally extorting Rs 1,500 crore annually. He accused the BJP government of attempting to suppress the scam and failing to take any substantial action.

Key allegations and findings:

★ No investigation was



conducted into documents seized from Saurabh Sharma, and his arrest was delayed by 41 days.

★ Call Detail Records (CDR) of Saurabh Sharma's phone were not released, which could expose major leaders and officials involved.

★ Govind Rajput allegedly managed the entire racket from his office.

★ Between 2019 and 2024, Rajput amassed over Rs 600 crore in assets in the names of his family members.

★ In 2023, he concealed assets worth Rs 134 crore in his affidavit.

★ Land dealings were manipulated under the guise of donations through Gyan Veer

Committee.

★ Rajput and his business partners allegedly purchased properties in Delhi's Defence Colony.

★ A central minister was reportedly receiving Rs 2 crore per month from the transport department.

Singhar demanded an impartial investigation and strict action against the culprits. He also announced plans to submit a formal complaint to Prime Minister Narendra Modi in Bhopal.

The Madhya Pradesh Congress has called for a high-level inquiry and stringent action against all corrupt leaders and officials involved. Committed to the public interest, the party vowed to fight this battle at every level.

Lions released to display for tourists at Van Vihar

Bhopal: The majestic Asiatic lions brought from Shakkarbha Junagadh Gujarat on December 21, 2024 under the wildlife exchange scheme in Bhopal's Van Vihar National Park were released from the quarantine enclosure on February 15 morning for display to tourists.

Director Van Vihar said that among the two Asiatic lions, one is male Juna and the other is female Gir. Both these lions were quarantined in the enclosure and were being continuously monitored. At present, both the lions are completely healthy.

The lions, both approximately three-year-old, were brought from Shakkarbha Zoo in Junagadh of Gujarat, on Dec 21, 2024. In exchange for the lion pair, Van Vihar National Park has sent a male tiger (Bandhavgarh-2) and a female tiger (Bandhani), both approximately six-year-old, to Sakkarbaug Zoo. The exchange was conducted under the Central Zoo Authority approved exchange programme.

On Dec 17, a nine-member team from Van Vihar National Park transported the tigers to Sakkarbaug Zoo. The team, which included the in-charge of tourism and an assistant wildlife veterinarian, returned with the lion pair. With the arrival of the

new lions, Van Vihar National Park now including existing lions Satya, Ganga, and houses two male and three female lions, Nandi.

CBSE Class 10, 12 examinations begin

Bhopal: The Central Board of Secondary Education (CBSE) 10th and 12th examinations have started on Saturday, 15 February morning. This examination is being conducted at 493 examination centers in Madhya Pradesh, while 36 centers have been set up in the capital Bhopal.

The first paper of the 10th board examination was English. The exam time was fixed from 10:30 am to 1:30 pm. Candidates had to report at the examination center before 10 am. No student was allowed entry after 10 am.

Student Aditya said that the paper was very easy, I had also

studied from the sample paper, so I was expecting a little difficult paper. Apart from this, Neha Bhaduria said that the paper was quite easy.

CBSE has made strict arrangements at the examination centers to prevent cheating and other unfair means. CCTV cameras have been in-

stalled at all the centers. The flying squad team was constantly engaged in inspection. Administrative officials also kept a watch to ensure smooth conduct of the examination. Students and parents were advised to follow the rules of the examination so that there is no inconvenience of any kind.
